LEADING A NEW RESPONSE TO SEXUAL VIOLENCE

As a Result of the Sexual Assault, Do You Have Concerns for Your:

SAFETY

- Do you feel safe at home, work and/or school?
- Are you being harassed or contacted by the assailant?

PRIVACY

- Are you concerned that your private information will be made public?
- Do you need help protecting your confidential records in a legal or disciplinary proceeding?

EMPLOYMENT

- Do you feel safe at work?
- Are you having trouble working?
- Do you need things to change at work?

LEADERS IN NATIONAL TRAINING

IMMIGRATION STATUS

- Are you worried about your immigration because of the assault?
- Is your immigration status in trouble?

EDUCATION

- Are you having trouble going to school because of the sexual assault?
- Do you feel safe at school?
- Do you need things to change at school?

HOUSING

- Do you feel safe at home?
- Do you need things to change where you live?

FINANCIAL SECURITY

- Do you have unpaid bills as a result of the sexual assault?
- Do you need public benefits or victim compensation?
